### **NUGENIA PLUS – PILOT COMPETITIVE PUBLIC CALL FOR RESEARCH PROJECT PROPOSALS**

The FP7-Euratom project NUGENIA-PLUS with the support of the Association NUGENIA addresses through this public call the priority topics identified in the NUGENIA Roadmap published in autumn 2013.

#### **General information**

- Call identifier: **NUGENIAplus-pilot-2014**
- Publication Date: **22 September 2014**
- Budget: **€ 2.593.702,17 (EC contribution)**
- Deadline: **28 November 2014, 17h00 (Brussels time)**
- Eligibility: According to FP7 Euratom rules for Collaborative Projects (CP). Participants from EU countries plus Switzerland (associated to FP7) and international European Interest Organisations are entitled to funding. Participants from third countries may receive funding exceptionally in justified cases but this is judged on a case by case basis and the European Commission cannot guarantee in advance the acceptance of the funding.
- Language of project proposals: English

#### **Brief summary of the expected call impacts**

- Selected proposals shall have a clear impact and added value to NUGENIA and the call domain in terms of on-going work in the technical areas, cross-cutting technical issues and optimisation of the relevant resources and equipment use within Europe.
- Key elements shall be provided for improving safety, public awareness on nuclear energy related issues for operating plant, plant lifetime management and new build construction.
- The projects results shall contribute to the major orientations on European energy policy and to overall nuclear energy public acceptance.
