This event is not only meant as a high-ranking discussion forum: The expected outcome includes a Memorandum/Shared Vision Paper on the perspectives of EU-EECA cooperation, which could become a guiding line for upcoming policy debates on joint activities at national, bilateral and community level. The document will be presented to SFIC, EC, the European Parliament, national authorities and organisations, as well as to lobby groups present in Brussels.

New FP7 calls published in July 2011

The 2012 FP7 work programmes were adopted by the European Commission on 19 July. The first series of calls for proposals, with a budget of over € 5.3 billion was launched on 20 July.

This years calls will make available nearly € 7 billion, representing Europe's biggest ever package of research and innovation investment. It covers a vast range of scientific disciplines, public policy areas and commercial sectors and is meant to contribute to advance scientific boundaries, increase European competitiveness and help solve global societal challenges such as climate change, energy and food security, health and an ageing population. The Seventh EU Framework Programme is also open to organisations from outside Europe.

On 27 July 2011 the European Commission's Directorate General for Research and Innovation organised an Information Meeting about the new calls for proposals under the 2012 Work Programme in Brussels.

The event provided detailed information on the activities targeted by the calls, namely the "Bi-regional coordination of S&T cooperation including priority setting and definition of S&T cooperation policies (INCONET)" and the "Bilateral coordination for the enhancement and development of S&T Partnerships (BILAT)". In particular, the specific focus of such activities and the new shift in their approach was described. The meeting was concluded by a Q&A session.

Decision makers and experts at ministerial level as well as key persons from research and science organisations in EU- and EECA-countries were invited to this exchange that meant to trigger new momentum for cooperation.

The agenda featured a number of current issues regarding bi-regional cooperation. A special focus was laid on analytical methods of policy advice such as the evaluation of research institutions, international benchmarking processes and the joint assessment of political strategies and concepts.

Innovation Performance Review of the Republic of Belarus now available in English and Russian

The 'Innovation Performance Review of Belarus' has initiated a new focus of activity for the United Nations Economic Commission for Europe, which draws on the experience accumulated so far in the identification of good practices and policy lessons in the area of knowledge-based development.

This Review presents the main outcomes of a participatory policy advisory exercise undertaken at the request of the Government of the Republic of Belarus. It aims to provide a set of recommendations and policy options to stimulate innovation activity in the country, enhance its innovation capacity and improve the overall efficiency of the national innovation system. It aims to contribute to the existing body of policy-relevant analytical work on policies promoting innovative development, thus facilitating the further identification of good practices in this area. The assessments and recommendations presented in the Review will serve to identify areas in which capacity-building activities can yield greater benefit, thus providing a solid basis for future work in this direction.

The Review is carried by the Committee for European Cooperation and Integration of ENECE and the State Committee for Science and Technology of Belarus. Presentation of the outcomes in Belarus is scheduled for autumn 2011.

State Program for the Development of Higher Education for 2011-2015

The State Program for Development of Higher Education in Belarus for 2011-2015 was approved by the Regulation of the Council of Ministers of 1 July 2011 № 893. It foresees a complex of measures aimed to increase the quality of training in accordance with the strategy of social and economic development of the country. Also, the document is focused on implementation of the main principles of higher education development in Belarus as a part of European educational system.

The Program includes such measures as upgrading of the educational programs, improving the qualification of trainers, increasing connections between education and industry/economy, as well as substantial renew of the material basis of universities.

Upon the results of the Program, 147 thous. university graduates and 9 thous. Master's degree holders will be trained with the financial support from the budget.

Agreement between Belarus and Italy on S&T cooperation signed

Belarus and Italy have signed an inter-governmental agreement on cooperation in science and technology. Upon the results of bi-lateral meeting in June 2011 in Trieste, Italy during the CEI ministerial meeting, the heads of the ministries of external affairs of Belarus and Italy Mr Sergey Martunov and Mr Franko Frattini finalized negotiations on this document which lasted for quite long time.

The Agreement sets up the framework conditions for developing long-term contacts between research centers and science-based companies of the two countries, including an information exchange.

Inter alia, setting up a bi-lateral commission on S&T cooperation is foreseen.

Proposal Writing Workshops organised by MOLD-ERA

The first round of Proposal Writing Workshops in the framework of FP7 MOLD-ERA project was held on June 29 – July 1 and July 4-6, 2011 in Chisinau, Republic of Moldova. The purpose of the events was to prepare and assist the researchers in better understanding the rules and regulations of FP7 and in writing successful proposals.

During the workshop the practical aspects of participation in the Framework Programme were presented by Michael Remes, from EFP Consulting LTD, which holds vast experience in FP management. The topics presented have aroused the interest of participants and resulted in various questions:

- Proposal writing
- Ethical aspects
- Evaluation process
- Project Financial Phases
- Project Best Practice

The two events were attended each by almost 30 representatives of the scientific community and academia, among them the State Medical and Pharmaceutical University "N.Testemitanu", State University of Moldova, the Institute of Mathematics and Computer Science, Information Society Development Institute, Institute of Applied Physics, Institute of Economy, Finance and Statistics, State University from Comrat, State University from Balti, as well as 6 NCPs.

The second and third day of the workshop were focused on practical activities, such as mock evaluation of a project proposal and consensus meeting, as well as determination of project costs, their justification and actually filling financial spreadsheets. The practical activities were especially valuable to the workshop and hopefully will result in a sound impact within Moldovan scientific community.

MOLD-ERA (Preparation for Moldova's integration into the European Research Area and into the Community R&D Framework Programs on the basis of scientific excellence) project is a Coordination and Support Action financed under the 7th Framework Programme. This is the first Framework Program project to be coordinated by the Republic of Moldova, namely by the Institute of Electronic Engineering and Nanotechnologies (IEEN).

The project aims to improve the level of training and equipment in the Nanotechnologies field in Moldova, which will lead to increased collaborations with EU institutions and improved career opportunities for young scientists in Moldova. The project will attract new investments and create new jobs, leading to a considerable increase in wealth for the Moldovan economy and society. It addresses the need for an enhanced scientific and research co-operation between Eastern European and the Southern Caucasus (EESC) countries and the EU, focusing on the International Co-operation theme of the FP7's Co-operation Programme.

Moldova: Second Open Call for Mobility - 2011

The second open call for grant scheme to support participation of researchers from Moldova in FP7 events was launched on the second of August 2011. The call was announced by the Academy of Sciences of Moldova, a partner of the consortium in the European Project IncoNet CA/SC.

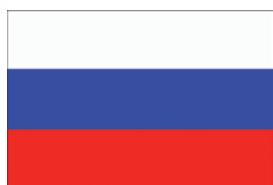
The **deadline** for submitting applications is **September 15**.

The grant concerns the participation of researchers (from Universities, Research Institutions and companies with RTD activity) from Moldova on specialized international brokerage events taking place in Europe. By order of priority, the events that will be chosen will be: Networking events organized by the EC, brokerage events organized in the framework of CSAs co-financed by the EC, large international events organized by other European networks (e.g Enterprise Europe Network).

The participation in brokerage events and RTD partnerships will provide an opportunity for the researchers to meet their counterparts, seek cooperation or potential partners and facilitate consortium building for future projects. It will also allow the researchers to make their institutions and / or their research networks better known. Particular emphasis will be placed on early stage researchers.

The events for which the second call grants will be given are expected to take place in late 2011 – early 2012.

German-Russian Government Consultations - science ministers agree on new common activities

The XIII. German-Russian Government Consultations took place on 19 July 2011. Government representatives of both countries came together to discuss bilateral cooperation in education and science.

On 23 May the German Federal Minister of Education and Research, Prof. Dr. Annette Schavan, and her Russian counterpart, Prof. Dr. Andrej Fursenko, had already launched the

German-Russian Year of Education, Science and Innovation 2011/12
(website in Russian and German language).

In the frame of their current consultations the ministers agreed upon measures and projects, which will be implemented in the coming months.

experience with the German dual education system is much sought after (The so called dual education system is practised in several countries, notably Germany, Austria and Switzerland. It combines an apprenticeship in a company with complementary education at a vocational school.). In this context both sides agreed to organise a 'German-Russian Conference on Vocational Education'. In addition a large number of conferences, symposia, workshops and exhibitions will be organised until May 2012 and take place in both Russia and Germany.

One of them will be a 'German-Russian Symposium on Knowledge and Technology Transfer as a Key Task for Universities within Society', and an other one a roadshow on common marine and polar research. Hands-on examples of German-Russian research will be presented to the public of both countries in various cities.

During their meeting the ministers also agreed to jointly take over the patronage for an initiative of the Goethe institute in Moscow: It is titled 'Deutsch unterwegs' and means to trigger and stimulate interest in the German language at more than 200 schools in 18 cities.

Talks also included the implementation of a joint German-Russian promotional programme for state-of-the-art research. Its aim is to optimize support for future projects e.g. concerning the protection and efficient use of natural resources. Schavan and Fursenko emphasized that these measures should also set an impulse for the exchange of young scientists.

Apart from this the federal minister and her Russian counterpart agreed to extend the cooperation in super computing and aim for a closer collaboration. In this context both ministers signed a Memorandum of Intent.

First European Union Centre opened in Siberia

On 4 July 2011 the Tomsk State University hosted an opening ceremony of the European Union Centre in Siberia (EUCES). The project is co-funded by the European Union and the Tomsk State University. It is the third EU centre of this kind in Russia – recently similar centres have been established in Kaliningrad and Saint-Petersburg.

The mission of the EUCES is to facilitate closer relations between the European Union and Russia as strategic partners through joint educational, research, innovative and outreach activities in the Tomsk Region and Siberia as a whole.

In Siberia and in the Tomsk region in particular, great attention is paid to education and innovation. The Tomsk Region is one of the most active participants to EU research and education programmes such as the Seventh Framework Programme, Tempus, Erasmus Mundus, etc. Therefore, the establishment of the EUCES is yet another opportunity to bring EU programmes closer to Tomsk and Siberia.
